## GIRL WILL RECOVER FROM SUICIDE ATTEMPT

Miss Elsie Siddall, the young Australian girl and former student at Stanford University, where she was working her way, will recover from her attempt at suicide made yesterday afternoon at the home of Mrs. E. G. Barnier. 2240 Twenty-Third avenue. Her condition was reported favorable at the Emergency Hospital today.

Three weeks ago Miss Siddall was released from the Napa Asylum where she underwent treatment for a mental derangement. She had planned to sail for her home in Australia within a few days and was staying with her sister Ida, a student at the University of California who lived in the home of Mrs. Barnier.

Fear of a recurrence of her malady is given as the cause for the young woman's despondency and her attempt to end her life by taking a solution of lye and slashing her wrists and throat with a shorp knife.
